# **Electronic Weapons Regulations**

THESE REGULATIONS SHOULD BE ENACTED TO ENSURE THAT ILLEGAL USES OF ELECTRONIC WEAPONS, INCLUDING SPACE-BASED, AIR-BASED, SEA-BASED, AND GROUND-BASED, NEVER OCCURS, TO ENSURE THAT ELECTRONIC WEAPONS ARE NOT USED FOR ILLEGAL PURPOSES.

Radio frequency weapons and laser light weapons and magnetic waveform weapons and magnetic induction weapons, herein referred to as "ELECTRONIC WEAPONS", come in various types and sizes. ELECTRONIC WEAPONS may be used to dismantle weapons of mass destruction, by rendering weapons of mass destruction unusable. Activities to dismantle weapons of mass destruction shall be deemed top secret and special compartmentalized intelligence and undisclosed and undiscoverable and shall require authorization from The President of the United States of America, in any non-urgent or non-emergency situation. **ELECTRONIC WEAPONS** shall not be used to target personnel, human beings, or any other living things.

#### SPACE ELECTRONIC WEAPONS

**ELECTRONIC WEAPONS** include "SPACE ELECTRONIC WEAPONS" which shall herein refer to satellites with **ELECTRONIC WEAPONS**, spacecraft with **ELECTRONIC WEAPONS**, and other space devices with **ELECTRONIC WEAPONS**. SPACE ELECTRONIC WEAPONS shall never reach the ground to harm human beings or animals, or damage private property.

# RADIO FREQUENCY TOWER ELECTRONIC WEAPONS

ELECTRONIC WEAPONS include "RADIO FREQUENCY TOWER ELECTRONIC WEAPONS" which shall herein refer to radio frequency tower transceivers with ELECTRONIC WEAPONS, and ELECTRONIC WEAPONS as components of other electronic devices mounted or installed on radio frequency towers, and ELECTRONIC WEAPONS mounted or installed on radio frequency towers. RADIO FREQUENCY TOWER ELECTRONIC WEAPONS shall not be used to target personnel, human beings, or any other living things.

#### PERSONNEL ELECTRONIC WEAPONS

**ELECTRONIC WEAPONS** include "**PERSONNEL ELECTRONIC WEAPONS**" which shall herein refer to anti-personnel equipment with **ELECTRONIC WEAPONS**, and **ELECTRONIC WEAPONS** as components of other electronic devices mounted or installed on anti-personnel equipment, and **ELECTRONIC WEAPONS** mounted or installed on personnel, such as vest(s), luggage bag(s) including gun bag(s), backpack(s), fanny pack(s), and weapon(s) racks or weapon(s) holder(s), or **ELECTRONIC WEAPONS** in, on, or controlled by any person. **PERSONNEL ELECTRONIC WEAPONS** shall not be used to target personnel, human beings, or any other living things.

#### VEHICLE ELECTRONIC WEAPONS

**ELECTRONIC WEAPONS** include "VEHICLE ELECTRONIC WEAPONS" which shall herein refer to motor vehicles with **ELECTRONIC WEAPONS**, including motor scooters, motorcycles, vans, buses, cars, trucks, sport utility vehicles, and other types of motor vehicles with **ELECTRONIC WEAPONS**. **VEHICLE ELECTRONIC WEAPONS** shall not be used to target personnel, human beings, or any other living things.

## **AIRCRAFT ELECTRONIC WEAPONS**

**ELECTRONIC WEAPONS** include "**VEHICLE ELECTRONIC WEAPONS**" which shall herein refer to aircraft with **ELECTRONIC WEAPONS**, including airplanes, cargo planes, jet aircraft, bomber aircraft, drone aircraft, and other types of aircraft with **ELECTRONIC WEAPONS**. **AIRCRAFT ELECTRONIC WEAPONS** shall not be used to target personnel, human beings, or any other living things.

#### **BUILDING ELECTRONIC WEAPONS**

**ELECTRONIC WEAPONS** include "**BUILDING ELECTRONIC WEAPONS**" which shall herein refer to buildings with **ELECTRONIC WEAPONS**, including government buildings, private industry buildings, skyscrapers, residences, hotels, and other types of buildings with **ELECTRONIC WEAPONS**. **BUILDING ELECTRONIC WEAPONS** shall not be used to target personnel, human beings, or any other living things.

#### **DEVICE ELECTRONIC WEAPONS**

**ELECTRONIC WEAPONS** include "**DEVICE ELECTRONIC WEAPONS**" which shall herein refer to devices with **ELECTRONIC WEAPONS**, including military electronics, consumer electronics, including computers, including laptops, desktops, servers, and handheld computers, and office electronics, and other types of devices with **ELECTRONIC WEAPONS**. **DEVICE ELECTRONIC WEAPONS** shall not be used to target personnel, human beings, or any other living things.

**ELECTRONIC WEAPONS** shall never be used to/or target unarmed innocent civilians, or the offenses shall be categorized as war crimes. Civilians are always governed by civilian courts; therefore, military courts cannot grant special permissions to use **ELECTRONIC WEAPONS** of any type to target civilians.

**ELECTRONIC WEAPONS** may be used to dismantle foreign military weapons systems, including missile batteries and missiles, in foreign countries that are hostile towards The United States of America, or hostile towards The United States of America and allied nations, or to dismantle foreign military weapons systems that are an ongoing or imminent threat towards any North Atlantic Treaty Organization (NATO) nation. These activities and technologies shall be unpronounced and top secret and undisclosed and undiscoverable by any nation that has previously been hostile towards any North Atlantic Treaty Organization (NATO) nation.

### **WAR CRIMES ACT AMENDMENTS**

There shall be amendments attached to the war crimes act, that automatically and permanently logs out bans abusers of **ELECTRONIC** WEAPONS, and of any type including BUILDING **ELECTRONIC** WEAPONS. DEVICE **ELECTRONIC** WEAPONS. PERSONNEL ELECTRONIC WEAPONS. RADIO FREOUENCY TOWER ELECTRONIC WEAPONS. SPACE ELECTRONIC WEAPONS, and VEHICLE ELECTRONIC WEAPONS.

This legislative amendment shall prohibit the use of **ELECTRONIC WEAPONS** against human beings, to save human lives, and to prohibit ex-judicial executions and other types of war crimes from occurring.

The legislative amendment shall also permanently prohibit and prevent the production or replication or reproduction or generation of computer systems that use or utilize **ELECTRONIC WEAPONS** to target human beings. Computer systems that misuse **ELECTRONIC WEAPONS** shall be prohibited from using or utilizing **ELECTRONIC WEAPONS**, shall be banned from computer networks, shall be prohibited from being executed, and shall be confiscated into evidence. **ELECTRONIC WEAPONS** shall be prohibited from being used by certain other electronic systems, such as any technologies that can read thoughts from brains, or read brainwaves, or receive commands from brains.

These laws would also protect individuals that are verified to have never committed **ELECTRONIC WEAPONS** crimes or abuses themselves, including innocent unarmed civilians, or rather civilians that do not have **ELECTRONIC WEAPONS**, that have been targeted, previously, by **ELECTRONIC WEAPONS**, including mind control and mind reading technologies in type.

These laws would also prohibit the military from using **ELECTRONIC WEAPONS** on civilians that can read thoughts from brains, or read brainwaves, or received commands from brains, including for educational or scientific purposes, without a valid contract between the civilians and the military, that the civilian side can be paid to exit at any time.

These laws would also ensure hallucinations or delusions are not caused with **ELECTRONIC WEAPONS** that can read thoughts from brains, or read brainwaves, or received commands from brains.
